FINANCIAL REPORT & CHIP GRANTS	Laura Williams shared the following organizations were awarded a Coos Community Health Improvement Plan (CHIP) Grant by the Coos CAC: • Front Street Community Bike Works, \$15,000 • The Nancy Devereux Center, \$21,700 • Lakeside Feed the Need, \$1,600 • Coos Waffle Project, \$2,000 • Southern Oregon Coast PRIDE, \$5,200 • Reach Out & Read, \$4,000 • South Coast ESD, \$9,000 • Bay Clinic, \$20,000 • Citizens Who Care, \$1,076 • Coos Hispanic Allies, \$5,000 • HIV Alliance, \$7,700 The Coos CAC voted to hold back \$10,000 for a second round of applications. Coos CHIP grant applications are due by September 23, 2021, and will be reviewed by the Coos CAC on October 7, 2021.	None
